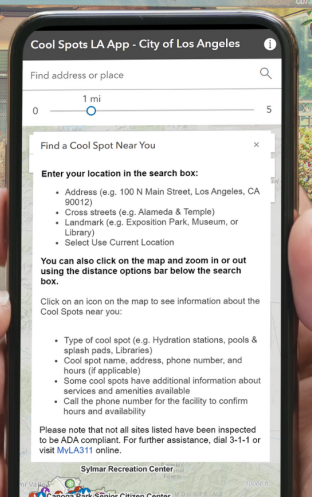

## UNEQUAL IMPACTS OF EXTREME HEAT

Extreme heat waves have increased by 6X since early 2000. Heat waves are now longer, more frequent, and last through mid-November. For LA and other similar cities, extended heat seasons make outdoor activity dangerous and harmful to our health.

In addition, we know that heat stagnates air pollution. In communities burdened by excessive air pollution and pre-existing health conditions, there are up to 3.5X the number of emergency room visits, perhaps more as these numbers are undercounted.

### DID YOU KNOW?

More than any other climate hazard in LA, extreme heat is causing more hospital admissions and fatalities.

Although extreme heat affects everyone, low-income residents and communities of color are shown to be disproportionately affected.
